## WARRANTY INFORMATION

### LIMITED WARRANTY SEATING

LOC Scientific, Inc. warrants its seating products against defects in material and workmanship for 15 (fifteen) full years. Lifetime on all pneumatic lifts, 5 (five) years on upholstery.

LOC Scientific, Inc. warrants its metal and wooden stools against defects in materials and workmanship for 3 (three) full years.

LOC Scientific, Inc. warrants its mesh office chairs and mesh guest chairs against defects in materials and workmanship for 5 (five) full years, lifetime on all pneumatic lifts, 5 (five) years on upholstery. This warranty does not apply to damage resulting from shipment, storage, alteration, misuse or normal wear.

### WARRANTY CONDITIONS

LOC Scientific, Inc. warrants its products to be free from defects in material and workmanship from the date of their original purchase, for normal commercial use and for the applicable warranty period specified. The LOC Scientific, Inc. warranty extends only to original purchasers acquiring new products for commercial use directly from LOC Scientific, Inc., its authorized dealers, or others specifically authorized by LOC Scientific, Inc. to sell its products.

The warranty does not apply to damage caused by the carrier; customer modification of product; attachments to a product; non-standard materials selected by and used at the request of a customer; or products which are not installed or used in accordance with the LOC Scientific, Inc. published instructions.

LOC Scientific, Inc.'s obligation and the purchaser's sole remedy under this warranty are limited as follows: repair or replacement, at the company's option, F.O.B. its plant. Purchasers may be required to establish that a claim is within the warranty period by producing the invoice for the product or other proof of purchase which is reasonably satisfactory to LOC Scientific, Inc. LOC Scientific, Inc. makes no warranty to purchasers who acquire products for personal, family, or household purposes. No person, firm, or corporations authorized to assume for LOC Scientific, Inc. any liability in connection with the sale or installation of the LOC Scientific, Inc. products except as stated above. THERE ARE NO OTHER WARRANTIES EXCEPT AS EXPRESSLY SET FORTH ABOVE. EITHER EXPRESSED OR IMPLIED INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE. The remedies stated herein are expressly agreed to be exclusive as a condition of sale, and LOC Scientific, Inc. liability with respect to its products shall not exceed that expressly set forth above regardless of the theory upon which any claim might be based, including breach of contract, warranty, negligence, or strict liability in tort.
